Reference is invited to the notification KFCSC/MKT/ADY/30/2019-20 Date: 07/05/2020 regarding "Request for Proposal, Empanelment of suppliers for supply of Tur Dal under Akshara dasoha Scheme of Government of Karnataka for academic year 2020-21 under e-procurement mode.

The following amendments for the respective Clauses have been incorporated.

A. EXISTING CLAUSE:

- 2.1 b) The eligible Individuals or partnership firm, Registered Company or Co-operative society or Dal Millers/Processors /Traders should have minimum average trade turnover of Rs Two crore (Rs.2.00 crore) in the past two years. The average trade turnover shall be computed for 2017-18 and 2018-19.

The above clause is deleted and amended as follows:-

- 2.1 b) The eligible Individuals or partnership firm, Registered Company or Co-operative society or Dal Millers/Processors /Traders should have minimum average trade turnover of Rs Twenty-Five crores (Rs.25.00 crore) in the past two years. The average trade turnover shall be computed for 2018-19 and 2019-20.

B. EXISTING CLAUSE:

- 3.13 DD drawn for Rs.10000/- Plus GST @ 18 % as applicable (Total amount Rs.11800/-)in favour of "Karnataka Food and Civil Supplies Corporation Limited" Payable at Bangalore towards application fees shall be enclosed along with application for registration. Suppliers who have not renewed membership with NCDEX e Markets Limited for 2020-21, shall pay registration fee of Rs.5000/- Plus GST (Total amount Rs.5900/-) as

applicable. The registration fee shall be remitted by way of electronic fund transfer in the following NCDEX e Markets Ltd (NeML) account for participation in e-auction. The details of fund transfer towards registration charges shall be mentioned in the application furnished vide Annexure-2.

The above clause is deleted and amended as follows:-

3.13 DD drawn for Rs.10000/- Plus GST @ 18 % as applicable (Total amount Rs.11800/-) in favour of "Karnataka Food and Civil Supplies Corporation Limited" Payable at Bangalore towards application fees shall be enclosed along with application for registration. Suppliers who had done their registration with KFCSC by paying Rs.53000/- are exempted from paying Rs.11800/- for the Academic Year 2020-21 .Suppliers who have not renewed membership with NCDEX e Markets Limited for 2020-21, shall pay registration fee of Rs.5000/- Plus GST (Total amount Rs.5900/-) as applicable. The registration fee shall be remitted by way of electronic fund transfer in the following NCDEX e Markets Ltd (NeML) account for participation in e-auction. The details of fund transfer towards registration charges shall be mentioned in the application furnished vide Annexure-2.
