Reference is invited to the notifications KFCSC/MKT/ADS/26D/2020-21/ Date:02.12.2020, KFCSC/MKT/ADS/26E/2020-21/ Date: 18.12.2021, KFCSC/MKT/ ADS/26F/2020-21/Call-2 Date:23.12.2020 and KFCSC/MKT/ADS/26G/2020-21Call-3 Date: 07.01.2020 regarding "Request for Proposal for Empanelment of Suppliers for Supply of Sunflower Oil under Mid Day Meal Scheme" of Government of Karnataka for the academic year 2020-21.

#### **Existing Clause:**

#### **3. Empanelment of Suppliers**

c) Quantities supplied in excess of the quantity specified in the purchase order will not be paid for. Supply of required quantity should be as indented by the District Manager of the KFCSC. The District Manager of KFCSC at his sole discretion may place purchase orders/ indents by letter/ e-mail, pending execution of agreement. The successful qualified supplier is bound to honor such indents and shall arrange to supply fifty percent (50%) of requisite quantity of refined sunflower oil to the designated locations, within fifteen (15) days and remaining fifty percent (50%) of requisite quantity within subsequent fifteen (15) days from the date of purchase order/ indents by the DM's to deliver commodities indented for supply. Entire supply to be completed within thirty (30) days from the date of purchase orders/ indents by DM's to deliver commodities indented for supply suppliers are bound to adhere to such delivery schedules without fail.

The above clause issued under vide Notification No. Corrigendum-3, Refined Sunflower Oil, KFCSC/MKT/ADS/26G/2020-21/CALL-3/198 Date: 16.04.2021 remains cancelled.

Further the RFP clause (3) Empanelment of suppliers, sub clause (c) is amended as “The successful qualified supplier is bound to honor such indents and shall arrange to supply fifty percent (50%) of requisite quantity of refined sunflower oil to the designated locations, within five (05) days and remaining fifty percent (50%) of requisite quantity within subsequent ten (10) days from the date of purchase order/ indents by the DM’s to deliver commodities indented for supply. Entire supply to be completed within fifteen (15) days from the date of purchase orders/ indents by DM’s to deliver commodities indented for supply.”

The above amendment will come into force with immediate effect and will be applicable for Iodised salt and Toordhal also.
